

**BIRCH RUN TOWNSHIP
Saginaw County, Michigan**

**(Resolution Confirming Maple Road
Water Main Extension District Special Assessment Roll)**

At a regular meeting of the Township Board of the Township of Birch Run, Saginaw County, Michigan, held at the Township Hall on the 10th day of May, 1994, at 7:30 o'clock p.m. Michigan Time.

PRESENT: Magnum, DiBerardino, Hayes, Russell, Strahm

ABSENT: St. Charles

The Township Supervisor announced that this was the time fixed for hearing and considering any objections to the Maple Road Water Main Extension Special Assessment Roll made to assess lands and premises in the Township the cost of acquiring a water supply system to be located in the Township as follows:

An 8-inch water main measuring 909 feet located beneath the Dixie Highway in the vicinity of Maple Road, to be connected to the current water main located adjacent to the Dixie Highway, together with the installation of one fire hydrant.

No written or oral objections were received except as follows:

The Township Supervisor thereupon declared the hearing closed.

The following resolutions were offered by Russell and seconded by Hayes:

WHEREAS, this Township Board has heretofore approved the construction of a water supply system to be located in the Township as described above, and the assessing of the cost of such

acquisition to a special assessment district to consist of the lands and premises in the special assessment district, to-wit:

A part of the W 1/2 of the SW 1/4 of Section 8 described as follows: Commencing at the W 1/4 post of Section then S 0°29'10" E 1049.59 feet along W section line to the centerline of Dixie Highway then S 29°31'40" E 277.13 feet along said centerline thence N 60°28'20" E 1373.97 feet perpendicular to centerline of Dixie Highway to W 1/8 line thence N 0°30' W 634.13 feet to 1/4 line then S 89° W 1335.62 feet to Point of Beginning, except commencing at W 1/4 corner then S 894 feet to Point of Beginning then E 300 feet thence S 126.52 feet thence S 61° W 48.89 feet thence W 256 feet to centerline of Dixie Highway then N 28° W 2.59 feet to intersection of said centerline with W section line then N 147.73 feet to Point of Beginning, T10N R6E.

WHEREAS, this Township Board has met on this date for the purpose of hearing and considering any objections to special assessment roll for such project.

THEREFORE, BE IT RESOLVED BY THE TOWNSHIP BOARD OF THE TOWNSHIP OF BIRCH RUN, SAGINAW COUNTY, MICHIGAN, as follows:

1. This Township Board hereby approves and adopts the Maple Road Water Main Extension District Special Assessment Roll together with the Certificate of the Township Supervisor set forth in Exhibit "A" hereto, made to defray the cost of constructing a water supply system to be located in the Township as above described.

2. That this Township Board does hereby determine that such assessments be collected in 20 equal annual installments and the Township Treasurer is hereby directed to spread such assessments annually on the Township's tax rolls.

3. That such assessments shall be levied and collected each year in the same manner as the Township taxes. Penalties for late payments shall be the same as the penalties for late tax payments.
