RESOLUTION TO ESTABLISH ADMINISTRATION FEES FOR ORDINANCE #2011-01 AND
#2006-04

At a Regular Meeting of the Birch Run Township Board, Township of Birch Run, Saginaw County, Michigan, held at the Township Meeting Room on the 12th day of July, 2011, at 7 o'clock Eastern Standard Time.

The following resolution was made by Marr and seconded by Nelson:

WHEREAS, on November 14, 2006, the Township of Birch Run adopted Ordinance #2006-04, "The Township of Birch Run Public Nuisance Ordinance"; and

WHEREAS, the Township of Birch Run amended Ordinance #2006-04 on July 12, 2011; and

WHEREAS, the amendment of Ordinance #2011-01 documents the additional time and expenses that are incurred with administering Ordinance #2006-04; and

WHEREAS, the Zoning Department is recommending to the Township Board that an administrative fee of \$100.00 be charged to all property owners being sent a second notification as stated in Section 6 (C) and an hourly rate of \$80.00 per hour minimum or the actual cost to the jurisdiction (a fraction of an hour shall be charged the full hourly rate) for mowing be charged for carrying out the provisions of said ordinance in addition to the fines as stated in Section 6 and Section 9.

THEREFORE, BE IT RESOLVED, that the Township Board of the Township of Birch Run, by an affirmative vote of its members, does hereby authorize that an administrative fee of \$100.00 be charged to all property owners being sent a second notification as stated in Section 6 (C) and an hourly rate of \$80.00 per hour minimum or the actual cost to the jurisdiction (a fraction of an hour shall be charged the full hourly rate) for mowing be charged for carrying out the provisions of said ordinance and the associated charges as stated in Section 6 & 9.
