RESOLUTION TO ESTABLISH TOWNSHIP OFFICERS SALARY  
NO. 10-07**

At a Regular Meeting of the Birch Run Township Board, Township of Birch Run, Saginaw County, Michigan, held at the Township Meeting Room on the 9<sup>th</sup> day of February, 2010, at 7 o'clock Eastern Standard Time.

**PRESENT:** Cook, Kiessling, Trevino, Nelson, and Marr

**ABSENT:** Magnus and Strahm

The following resolution was made by Nelson and seconded by Marr:

**WHEREAS**, Michigan Compiled Law 41.95 authorizes the township board of Birch Run Township to determine the salaries for the offices of Supervisor, Clerk, Treasurer, and Trustee for fiscal year 2011 by adopting a resolution at least 30 days prior to the township annual meeting, and

**WHEREAS**, on February 9, 2010 the township adopted a resolution to hold the township annual meeting on March 23, 2010, and

**WHEREAS**, the township board does not deem it necessary to raise the wages of the elected township officials at this time, now

**BE IT RESOLVED**, that as of April 1, 2010 the salary of the township board member shall be as follows:

**Treasurer: \$27,000**

**BE IT ALSO RESOLVED**, that this resolution shall be submitted to the electors of the annual meeting to be held on March 23, 2010 at which time the electors may modify this amount. Pursuant to MCLA 41.95(7), such modification(s) that may be made by the electors cannot result in a reduction of salary during each official's term of office. In the event that the electors fail to act on this resolution, the officer shall be entitled to the salary as established in this resolution, in accordance with state law.

**BE IT FURTHER RESOLVED**, that this resolution, adopted this day, February 9, 2010 is properly adopted by the Birch Run Township Board at least 30 days prior to the annual meeting as required by law.
