WHEREAS, during the period of February 9, 2010 the Township Board conducted a budget review session and recommended adjustments to bring expenditures and revenues into conformity of a balanced budget for the several funds, and

WHEREAS, the proposed budget for the fiscal year 2011 was filed with the Clerk on February 9, 2010 and the Township Board duly held a public hearing on the 2011 proposed budgets as required by law on March 9, 2010 in the Government Meeting Room, 11935 Silver Creek Drive, Birch Run, Michigan 48415;

NOW THEREFORE BE IT RESOLVED that the Birch Run Township Board hereby approved the 2011 operating budgets (Appropriations Act) for the General, Library, Water, and Sewer Funds as follows for the fiscal year beginning April 1, 2010
