WHEREAS, the Construction Board of Appeals shall consist of not less than three (3) nor more than seven (7) members that shall serve two-year terms, and

WHEREAS, the Chief Executive Officer of the Township shall appoint members to the Construction Board of Appeals, and

NOW BE IT RESOLVED, that the Birch Run Township Board shall reaffirm the following appointees to the Construction Board of Appeals;
