

RESOLUTION NO. 97-6
BIRCH RUN TOWNSHIP BOARD
NOVEMBER 11, 1997

WHEREAS, Birch Run Township has retained the services of Ivan V. Bartha, P.E. of Traffic Engineering Associates, Inc. to evaluate and report on roadway and safety conditions in the Township; and

WHEREAS, Mr. Bartha has issued a report regarding roadway and safety conditions on South Beyer Road and its intersection with Burt Road in Birch Run Township; and

WHEREAS, the report indicates that substandard and dangerous roadway conditions exist on South Beyer Road from its intersection with Burt Road and north approximately 2500 feet; and

WHEREAS, Mr. Bartha's report recommends a temporary moratorium on any commercial development in this area until needed road improvements can be completed; and

WHEREAS, this segment of South Beyer Road including the intersection of South Beyer Road and Burt Road are under the jurisdiction of the Saginaw County Road Commission; and

WHEREAS, the Township Board has carefully considered the report of Mr. Bartha and has determined to follow his recommendation for the protection of the public safety and welfare.

NOW THEREFORE BE IT RESOLVED that the Birch Run Township Board adopts a temporary moratorium on commercial development in the area of South Beyer Road from its intersection with Burt Road north 2500 feet and including the intersection of South Beyer Road and Burt Road, until needed road improvements are completed by the Saginaw County Road Commission.

BE IT FURTHER RESOLVED that the Birch Run Township Board directs that no further building permits shall be issued for the affected area for the period of the moratorium.

BE IT FURTHER RESOLVED that the Clerk is directed to send a certified copy of this resolution to the Saginaw County Road Commission.

BE IT FURTHER RESOLVED that the Clerk is directed to send certified copies of this resolution to the owners of affected properties adjoining the road and intersection.

BE IT FURTHER RESOLVED that the Township will cooperate with the Saginaw County Road Commission in expediting the necessary road improvements, and that the Township Supervisor or his designated representative remains willing to meet with the Commission or its representatives for this purpose.


