

BIRCH RUN TOWNSHIP  
ORDINANCE NO. 91 - 6

AN ORDINANCE TO ADOPT THE 1991 EDITION OF THE UNIFORM CODE FOR THE ABATEMENT OF DANGEROUS BUILDINGS.

THE TOWNSHIP OF BIRCH RUN TOWNSHIP ORDAINS:

SECTION 101. TITLE

This Ordinance shall be known as the Birch Run Township Abatement of Dangerous Buildings.

SECTION 102. PURPOSE

It is the purpose of this Ordinance to regulate the orderly procedure for remedying dangerous buildings located within the Township of Birch Run; and, to further provide for the issuance of permits and collection of fees and levy of penalties for the violation of provisions as set forth.

SECTION 103. ADOPTION OF UNIFORM CODE

The Township of Birch Run elects to adopt the Uniform Code for the Abatement of Dangerous Buildings, 1991 Edition, published by the International Conference of Building Officials, one copy of which is on file in the office of the Township Clerk, and made a part hereof as if fully set out in this ordinance.

SECTION 104. REPEAL AND SAVING CLAUSE

All other ordinances or parts of ordinances inconsistent or in conflict are repealed. This repeal shall not abate any action now pending under or by virtue of the ordinance repealed, nor shall the repeal discontinue, abate, modify or alter any penalty accrued or to accrue or effect the rights of any person, firm or corporation, or waive any rights of the Township of Birch Run, under action of the ordinance repealed existing at the time of the passage of this ordinance. It shall be considered that this ordinance is repealed upon the effective date of this ordinance.

SECTION 105. EFFECTIVE DATE

This ordinance shall become effective 30 days from the date of publication.
