At a Regular Meeting of the Township Board of the Township of Birch Run, Saginaw County, Michigan, held at the Township Meeting Room on the 9TH day of July 2002, at 7 o'clock Eastern Standard Time.

The following resolution was made by Ed Magnus and seconded by Debbie Trevino:

WHEREAS, it is a requirement that the governing body specifically designating a hardship property tax reduction adopt a resolution based on a taxpayer's inability to pay property taxes or the taxpayer's poverty according to MCLA 211.7u. The hardship reduction is only available to residents of Birch Run Township for their homestead.

NOW, THEREFORE, BE IT HEREBY RESOLVED:

- 1. That the Board of Review will objectively evaluate hardship reduction applications utilizing all available information, including statements, under oath, by applicant upon appearance before the Board of Review.
- 2. A taxpayer must apply for hardship reductions on an annual basis.
- 3. That applicants will be qualified in one of three categories, Senior Citizens, Non-Senior Citizens and Recipient of public assistance from the State of Michigan.
- 4. That if the Birch Run Township Board of Review denies a homestead hardship reduction or exemption, the Board of Review must provide a written decision specifying the reasons for denial. The Board must advise the property owner that they may appeal the decision to the Michigan Tax Tribunal.
