BIRCH RUN TOWNSHIP RESOLUTION APPROVING SUBMISSION OF BOND PROPOSITION TO ELECTORS NO. 05-10

At a Regular Meeting of the Birch Run Township Board, Township of Birch Run, Saginaw County, Michigan, held at the Township Meeting Room on the 9th day of August, 2005, at 7 o'clock Eastern Standard Time.

The following resolution was made by Trevino and seconded by Magnus

WHEREAS, pursuant to Act No. 116, Public Act of Michigan, 1923, as amended, the Township of Birch Run (the "Township") is authorized to borrow money and issue its bonds for the purpose of acquiring, erecting, equipping, and furnishing buildings in the Township to be used for public purposes; and

WHEREAS, this Township Board has determined that it is appropriate to submit a bond proposition to the electors of the Township at the General Election to be held on November 8, 2005.

NOW, THEREFORE, BE IT RESOLVED by the Township Board of the Township of Birch Run, as follows:

1. The following proposition shall be submitted to the electors of the Township at the General Election to be held in the Township on November 8, 2005, to wit:

FIRE STATION BOND PROPOSITION

Shall the Township of Birch Run, Saginaw County, Michigan, borrow an amount not to exceed four million two hundred thousand dollars (\$4,200,000.00) and issue its general obligation unlimited tax bonds therefore for the purpose of paying the costs of acquiring, erecting, equipping, and furnishing a fire station in the Township and acquiring and improving the site therefore? The maximum number of years the bonds may be outstanding, exclusive of refunding is 20 years; the estimated millage that will be levied to pay the proposed bonds in the first year that the levy is authorized is 1.58 mills (which is equal to \$1.58 per \$1,000 of taxable value of real and personal property in the Township); and the estimated simple average annual millage that will be required to retire the bond is 1.40 mills.

- 2. The Township Clerk is hereby directed to do all things necessary to provide for the submission of the aforesaid proposition to the electors of the Township at the General Election to be held on November 8, 2005.
- 3. All resolutions and parts of resolutions, insofar as the same may be in conflict herewith, are hereby rescinded.

NOW, THEREFORE, BE IT RESOLVED by the Township Board of the Township of Birch Run, as follows:

1. The following proposition shall be submitted to the electors of the Township at the General Election to be held in the Township on November 8, 2005, towit:

POLICE PROTECTION MILLAGE PROPOSITION

Shall the limitation upon the total amount of general ad valorem taxes imposed upon real and tangible personal property for all purposes in any one year under Michigan law be increased for the Township of Birch Run, Saginaw County, Michigan, by 2 mills (which is equal to \$2.00 per \$1,000 of taxable value of all such property) for a period of 5 years, 2006 through 2010, inclusive, for the purpose of providing police protection in the Township. The proposed millage is a new additional millage. The amount of revenue the Township of Birch Run will collect if that millage is approved and levied by the Township in the first calendar year is estimated to be \$378,644.76.

- 2. The Township Clerk is hereby directed to do all things necessary to provide for the submission of the aforesaid proposition to the electors of the Township at the General Election to be held on November 8, 2005.
