Motion by Russell, supported by Hayes to approve \$870 siren repair to be paid from Township Center Building/Equipment repair account. Motion carried 6-0.

Motion by Russell, supported by Hayes to approve General Fund revenue adjustment of \$2654.32 to reflect money received from sale of tanker truck. Motion carried 6-0.

Motion by Russell, supported by Strahm to approve following budget adjustments: Increase Fire Dept. Education by \$300, increase Fire Dept. Medical by \$750, increase Fire Dept. Repair/Equipment by \$1550. Motion carried 6-0.

Motion by Zietz, supported by Russell to authorize body work, insulation, and lettering on #4 Fire Truck, omitting lightbar and siren item, for a cost of \$3126.05 as presented. Motion carried 6-0.

Motion by Strahm, supported by Russell to set date for Public Hearing on Recreation Plan, January 25, 1994, at 7:30 p.m., at Birch Run Township Center, 8411 Main Street. Motion carried 6-0.
