Motion made and supported that we pay \$0.50 per hour for board labor for Road work Carried

Resolved that pursuant to the provisions of the law of the State of Michigan, including but not as limited to Act # 40 of the Public Acts of 1934 as amended by Act # 77 of Public Acts of 1933 and by Public Acts # 18 of 1935 and also Act # 98-95-100 of Public Acts of 1935; and Act 257 of Public Act of 1939 the Township Board of Birch Twp Township does hereby designate the Birch Twp State Bank as the depository for all Public money including taxes collected coming into the hands of the Treasurer of the Birch Twp Township and does hereby direct Edgar Pollet Treasurer of said Township to deposit any and all public money coming into his hands as such Treasurer in said Birch Twp State Bank of Birch Twp Mich

Motion made that all money received by the Township of Birch Twp for use and servicing of Fuel Equipment that are now in the possession of Ed Pollet will be returned from whom it came as the Township does not claim any right of ownership of said equipment Motion made by Baile and supported by Sherman Stuckentrick Carried
