Update on Outdoor furnaces: Section 5 A: change a planned unit development within Birch Run Twp.

Added section E: An outdoor furnace shall have a permanent chimney equipped with a spark arrestor which extends above the ground surface of at least 2 feet higher than the highest roof peak, within ten feet, of the outdoor furnace. In specific cases, based on the lay of the land surrounding structures and the current code requirements the inspector may require a higher chimney and 65 feet from a neighbor's house. Compliance with all manufacturing requirements to be met.

Section 5F, 5G not to be changed.

Motion made by Fred to accept proposed changes to accept the changes permitting outdoor furnaces as written, CJ seconded the motion. Passed unanimous.

Update on status of Wind Turbines, Outdoor Restaurant, Adult Entertainment: Recommendation made to the Twp. board March 19, 2012 from planning commission of all 3 ordinances of wind turbines and outdoor restaurant facilities and adult entertainment with additional needed proposal of refinement of the adult entertainment wording into a correct consistent format.
