- WHEREAS, it was the desire of this Township Board to approve and authorize the imposition of a late penalty charge in accordance with the provisions of 1982 PA 503 through Resolution #2001-15 (Property Tax Penalty Charge and Interest); and,
- THEREFORE, BE IT HEREBY RESOLVED, by the Township Board of Birch Run Township to rescind Resolution #2001-15 (Property Tax Penalty Charge and Interest) beginning with the 2024 Winter Taxes.
- BE IT FURTHER RESOLVED THAT, this authorization shall remain in effect until the Birch Run Township Board authorizes the imposing of such late penalty charge as allowed under MCL 211.44 in the future.
