**Miscellaneous Issue:**

- A.** Add the following; "The shooting range shall be fenced around its boundaries with a fence at least four feet high to clearly identify the boundaries of the shooting range. The range shall be clearly posted with warning signs around its perimeter. All vehicular access shall be controlled by locked gates.
- B.** No changes-keep at 5 acres minimum.

**Zoning Map:** Change coloring on zoning map and make A-1 and A-2 the same color.
