A motion to give the supervisor the authority to have an engineering study made of an area in the township to make application for FMHA grant if it seems feasible was made by Foster, supported by Scharrer. The motion passed unanimously.

A motion to change the rate for rental of the flail mower from \$25 to \$15 per hour for the village was made by Scharrer and supported by Foster. I he motion passed unanimously.

A motion to agree with the decision of the local and county planning commissions in denying rezoning request of Don Porter was made by Strong and supported by Foster. The motion passed unanimously.

A motion to approve the final payment to Grove Construction Company for the Birch Run Water System was made by Strong and supported by

Scharrer. The motion passed unanimously.

A motion to approve the Act 116 application of Don Morse was made by Block supported by Foster. The motion passed unanimously.

A motion to approve the five Act 116 applications of Barbara and Harold Scharrer was made by Scharrer supported by Block. The motion passed unanimously.

A motion to approve the two Act 116 applications of Wilbert and Frances Reif was made by Block, supported by Scharrer. The motion passed unanimously.

A motion to adjourn was made at 9:10 by Foster and supported by Scharrer. The motion passed unanimously.
