## RESOLUTION NO. 93-4 ESTABLISHING CHARGES FOR WATER SERVICE

The following resolut	ion was offered byLarry	Russell	_ and seconded by
Jackie Hayes	:		

WHEREAS, The Township of Birch Run , pursuant to Ordinance 76-1, adopted July 13, 1976, established charges for water service, and

WHEREAS, The Township of Birch Run has entered into an agreement, dated September 16, 1993, with the Village of Birch Run as to the adjustment of respective obligations of the Municipalities, and

WHEREAS, The Township desires to adjust the charges for water service paid by the water customers of the Township to reflect the September 16; 1993 agreement.

## NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The minimum charge for water service shall be increased by \$5.00 per quarter as follows: Original line to \$50.00 per quarter for first 10,000 gallons; Extension #1 to \$55.00 per quarter for first 10,000 gallons; Extension #2 to \$35.00 per quarter for first 10,000 gallons;
- 2. This amendment to Ordinance 76-1, dated July 13, 1976, shall be in effect from January 1, 1994 through March 31, 1998. At that time the charge for water service shall be reduced \$5.00 per quarter to the rates in effect prior to this amendment.
- 3. The aforementioned \$5.00 increase in charges for water service shall be set aside by the Township to assist in the payment of obligations agreed to in the agreement with the Village of Birch Run dated September 16, 1993.
- 4. All Resolutions and parts of Resolutions insofar as they conflict with the provisions of this Resolution shall be rescinded.
