A motion to amend treasurer's office supplies from \$500 to \$600 was made by Foster supported by Block.

A motion to amend tax roll processing from \$1700 to \$2500 was made by Block supported by Foster. Motion passed unanimously.

A motion to amend library budget from \$50,000 to \$57,000 was made by Block, supported by Foster. Motion passed unanimously.

A motion to adjourn was made at 9:10 p.m. by Scharrer supported by Block. Motion passed unanimously.
