RESOLUTION

By the Birch Run Township Board at a regular meeting held on the tenth day of June, 1980. Motion by Kyn Follow supported by Chan Schane

Whereas, at a regular meeting held on March 1, 1977, the Birch Run Township Board did appoint a committee to investigate the feasibility of and all phases of opening a library in Birch Run Township; and

Whereas, at a regular meeting on June 14, 1977 the Birch Run Township Board accepted the report of the feasability committee that a library was possible for Birch Run Township under the tenets of the 1955 school code act; and

Whereas, at the Proposed Use Hearing for Federal Revenue Sharing Funds held on April 1, 1978 the Birch Run Township Board proposed spending these funds for library/health center construction; and

Whereas, on April 1, 1978 at the annual meeting of the residents of Birch Run Township the proposed budget which included \$90,000.00 for library/health center construction was accepted; and

Whereas, at the Budget Hearing for Federal Revenue Sharing Funds held on April 11, 1978 the Birch Run Township Board decided to spend revenue sharing funds totaling approximately \$50,000.00 to build library/health center; and

Whereas, at a special meeting held on April 17, 1978 the Birch Run Township Board accepted the bid of \$89,500.00 from Wolgast Co. for construction of the library/health center; and

Whereas, at a regular meeting held on May 9, 1978 the Birch Run Township Board named the library the Thomas E. Fleschner Memorial Library; and

Whereas, at a regular meeting held on January 9, 1979 the Birch Run Township Board amended the capital outlay budget from \$90,000.00 to \$103,600.00 for library/health center construction; and

Whereas, at a regular meeting held on Jan. 9, 1979 the Birch Run Township Board named Library Bureau as supplier for library furnishings; and

Whereas, at a regular meeting held on February 13, 1979 the Birch Run Township Board set \$10 per year per family as the non-resident fee for use of Fleschner Library; and

Whereas, at the Proposed Use Hearing for Federal R venue Sharing Funds held on March 13, 1979 the Birch Run Township Board proposed using these funds for library equipment; and

Whereas, at the annual meeting of the residents of Birch Run Township held on March 31, 1979 the budget which included \$50,000.00 for Fleschner Library was approved; and

Whereas, at the Budget Hearing for Federal Revenue Sharing Funds held on March 31, 1979 the Birch Run Township Board decided to spend these funds on library equipment; and

Whereas, at a regular meeting held on April 10, 1979 the Birch Run Township Board decided to spend the equivalent of 3/10 of a mill on the township library per year; and

Whereas, at a regular meeting held on April 10, 1979 the Birch Run Township Board adopted the 1979-80 budget which included \$50,000.00 for library operations; and

Whereas, at a regular meeting held on April 10, 1979 the Birch Run Township Board passed a resolution to join the White Pine Library Co-operative; and

Whereas, at a special meeting held on May 15, 1979 the Birch Run Township Board named Tracie Curtis as librarian for the Fleschner Memorial Library; and

Whereas, at a regular meeting held on July 10, 1979 the Birch Run Township Board signed the White Pine Library Go-operative membership contract; and

Whereas, at a regular meeting held on January 8, 1980 the Birch Run Township Board amended the library budget from \$50,000.00 to \$57,000.00; and

Whereas, at the Proposed Use Hearing for Federal R venue Sharing Funds held on March 11, 1980 the Birch Run Township Board proposed using these funds for Fleschner Library; and

Whereas; at the annual meeting of the residents of Birch Run Township held on March 29, 1980 the budget including \$27,700.00 for library was approved; and

Whereas, at the regular meeting held on April 8, 1980 the Birch Run Township Board adopted the 1980-81 budget including \$27,700.00 for library.

Be it therefore, RESOLVED, that on this <u>fenth</u> day of <u>June</u>, 1980 that the Birch Run Township Board acting under the directives of the 1955 School Code Act hereby establishes a public library in and for the Township of Birch Run.
