A motion to pay the bills as read was made by Block and supported by Foster. The motion passed unanimously.

Supervisor reported that bids for the water line will be open on Oct. 24.

Supervisor reported that the State Highway Department will do a study to determine if corner of Gera and Birch Run Road merits a traffic light.

The one open space and four farmland agreement applications of Arno and Caroline Mossner were approved by motion of Block and supported by Foster. The motion passed unanimously.

The supervisor read a letter from the village requesting that interest on surplus funds in water construction be turned over to them.

A motion to approve this request for \$9,443.79 was made by Foster, supported by Block. Motion passed unanimously.

A motion to approve additions to the Wolgast Construction Company's contract to cover cost of catch basin repair (495) and clinic cabinents (\$2210) was made by Foster, supported by Block. The motion passed unanimously.

A motion to approve the contract with Anderson Radio for fire department radio services was made by Block, supported by Strong. The motion passed unanimously.

A motion to amend the miscellaneous township account from \$800 to \$1500 was made by Scharrer, supported by Block. The motion passed unanimously.

A motion to adjourn was made at 9:05 by Foster, supported by Scharrer. The motion passed unanimously.
