Bid from Schmitzer Hardware for heating and electrical was accepted by motion of Dorr and supported by Scharrer. Motion passed unanimously.

P.A. 116 application of Connie Reed was approved by motion of Scharrer and supported by Dorr. Motion passed unanimously.

P.A. 116 application of James and Sharon P. Dorr was approved by motion of Scharrer supported by Block. Motion passed unanimously.

Supervisor read letter from planning commission regarding rezoning petition of Magnus and Fox. Commission made recommendation to rezone. The board can take no action until Metropolitan Planning Commission makes recommendation.

P.A. 116 application of Clemence and Milda Polley was approved by motion of Block and supported by Scharrer. Motion passed unanimously.

Supervisor discussed Planning Commission's \$3,500 request for 83-84 budget.

Supervisor read letter from Mel Johnson in regards to proposed radio towers on corner of Gera and Busch Roads.

Supervisor read letter from Mrs. Thereas Payer complaining about July 4 expenditure. An answer will be sent.

Kenneth Hauck and Delmar Zuellig were reappointed to the planning commission for three year terms by motion of Block, supported by Dorr. Motion passed unanimously.

Purchase of copy machine for library was discussed. The consensus was to check into buying a machine.

A resolution of intent to amend the cable tv ordinance was made by Strong and supported by Block. Motion passed unanimously. Copies of changes are attached.

A motion to allow clerk and treasurer right to pay bills as they come due prior to close of fiscal year was made by Block and supported by Dorr. Motion passed unanimously.

Proposed budget was discussed by Board.

A motion to adjourn was made at 9:35~p.m. by Strong and supported by Scharrer. Motion passed unanimously.
