**RESOLUTION 2023-11

WHEREAS, the Township adopted an ordinance in February 2022 providing regulations applicable to recreational marijuana establishments in the Township (“Ordinance No. 2022-02”);

WHEREAS, the Township issued certain business licenses to applicants seeking to operate marijuana establishments in the Township pursuant to Ordinance No. 2022-02; and more specifically granted licenses as follows:

WHEREAS, the Township amended Ordinance No. 2022-02 through adoption of Ordinance 2023-05 that, following publication consistent with the terms of the amended Ordinance, became effective July 21, 2023;

WHEREAS, the Township wishes to confirm that the above identified licenses, issued pursuant to Ordinance No. 2022-02 remain in full force and effect and consistent with both Ordinance No. 2022-02 and Ordinance No. 2023-05; and

WHEREAS, the Township Board has determined that ratifying each and all of the above licenses pursuant to the authorities granted by Ordinance Nos. 2023-05 and 2022-02 and retroactive to the original date the licenses were issued (January 10, 2023) is in the best interest of the Township health, safety and welfare.
