Mike Rybicki from MLR Engineering and Keith Kosik from TSSF Architects are representing Frankenmuth Credit Union to request approval of a site plan and special-use permit to install a new drive up Automated Teller Machine (ATM) and the associated improvements.

iii. Applicant presentation

Mike Rybicki from MLR Engineering reviewed plans to relocate an existing, free-standing ATM to Frankenmuth Credit Union's permanent location at 9430 Meijer Drive South. He states initially, the machine will be temporarily located on the west side of the building until Spring, 2018 when it will be permanently installed. Keith Kosik of TSSF Architects states all electrical and underground utilities are already at the site. Rybicki states they will return to the Planning Commission in approximately 6 weeks with final site plans.

Schaar asks if a traffic volume study has been performed and Rybicki states he's unsure. Kosik states there are approximately 50 to 60 vehicles that currently use the stand-alone ATM. Sheridan asks if signs will be installed to let others know the new location of the ATM and Rybicki states yes. Schaar also asks if the water runoff situation will change once the permanent structure is installed. Rybicki states that currently, drainage runoff is to the south and the storm sewer will be extended. Schaar goes on to ask what distance the new ATM will be installed in the lot and Kosik states approximately 34 feet.

v. Staff Comments

Marr asks where the new ATM will be located and Kosik states on the southwest corner of the existing structure on Meijer Drive. Setzer reviewed the seven approval standards (see attached) and states they are adding an additional 8 parking spaces. Schaar asks if a light fixture will be relocated to the new ATM location. Rybicki states yes, on the northeast corner.

Rybicki goes on to state they will bring photo metric drawings when they return for their second meeting. Setzer states as long as they comply with the requirements stated from Rowe Professional Services Company. Schaar asks for a time frame of relocating the temporary ATM. Kosik states construction will start around March of 2018, pending the weather and the project should be completed by July, 2018.

Marr reviewed the seven approval standards and the general consensus of the Planning Commission was all standards have been met. Marr asks if more sewer installation will be needed for more restrooms and Kosik states yes. There will be one more restroom installed in phase 2. Close Public Meeting at 7:22 p.m.
