NOW, THEREFORE, BE IT RESOLVED, by this Board of Commissioners of Saginaw County, Michigan, that pursuant to the provisions of M.C.L.A. 78.2 through 78.4, that the question of making the proposed annexation and change of boundaries as requested the duly qualified electors of the Village of Birch Run and the Township of Birch Run be submitted to the qualified electors of said districts and that the same be submitted and placed on the ballot at the next general election, that being August 10, 1982.
