A motion to reappoint Kevin Lincoln as liquor inspector for the township was made by Scharrer, supported by Block. Motion passed unanimously.

Motion to increase Planning Commission members salary to \$25 per meeting by Scharrer, supported by Foster. Motion passed unanimously.

A motion to hire Ruth Mochy as township maintenance person was made by Scharrer, supported by Foster. Motion passed unanimously.

A motion to increase maintenance salary to \$4 per hour was made by Block, supported by Foster. Motion passed unanimously.

A motion to increase cemetery workers salary to \$4 per hour was made by Foser, supported by Block. Motion passed unanimously.

A motion to increase flail mower operator's salary to \$5 per hour was made by Foser, supported by Strong. Motion passed unanimously.

A motion to increase election inspectors salary to \$4 per hour was made by Foster, supported by Block. Motion passed unanimously.

Supervisor read letters from State Rep. Dodak and State Senator Young in regards to current legislation of concern to townships.

Supervisor read planning commission minutes.

A motion to grant Foster permission to purchase a tape recorder for Board of Appeals use was made by Block, supported by Scharrer. Motion passed unanimously.
