- WHEREAS Birch Run Township on December 12, 2003 adopted Ordinance # 03-02 Sign & Outdoor Advertising, and
- WHEREAS the purpose of the Sign & Outdoor Advertising Ordinance is to regulate signage and outdoor advertising within Birch Run Township, and
- WHEREAS the Sign & Outdoor Advertising Ordinance states that a permit must first be obtained from the Building Department with the exception of "exempt signs", and
- WHEREAS the Ordinance states that the Township Board shall by resolution establish the fees for a sign permit that relate to the cost of issuing the permit and the inspections
- **NOW BE IT FURTHER RESOLVED** that the fees for sign permits shall be based on the cost of construction of the signage, and.
- **BE IT FURTHER RESOLVED** that Birch Run Township Board adopts the following fee schedule to calculate the cost of sign permit fees.
