- 10 Section VII, Targets included in the "Action Plan"... The Board discussed a priority list for items wanted,
- 11 including;
- Picnic tables... More are needed
- Tennis Courts... Need repair
- Concession stand / trailer
- 15 Bill was to get with Ramon Rosa regarding "Plan Drafts"... Ramon will provide. Bill will get with Brad
- 16 Thomas regarding costs for playground material. Brad said on Jan 27th that the outstanding costs are;
- \$7,400.00 for materials yet to be purchased at a minimum and could be increased by \$2,300.00
- depending on the costs and availability of pea rock for the playground area.
- 19 The Board spoke on the placement of a building as possibly going between the play area and baseball
- 20 diamond.
- 21 A question was raised on the available space in the existing pavilion that could possibly be used for
- 22 concession vending. When asked, the BR Twp. Water department employees suggested the area in the
- 23 current pavilion could be MAYBE 6' X 10'.
- 24 Discussion followed on the scheduling of events and who actually schedules the park use. Paula Counts
- does the pavilion rental through the Township office, but there just seemed to be a disconnect as to the
- activity scheduling for things other than paid pavilion rentals. Apparently in the past, the Park was used
- 27 in somewhat of a haphazard fashion. There were **numerous** groups discussed that use the Park for their
- events. Follow-up discussion the next day in the Township office also added several other groups as
- 29 well.
- 30 A Township Board member suggested that every group that has used the Park in the past few years be
- 31 tasked with getting with every other group and submitting a "CONFLICT FREE" schedule to the
- 32 Township.
- 33 Editor's note: While this is laudable, the actuality of this actually occurring is extremely slim!!! From all
- reports the use groups do not communicate.

- 35 Bill was to make contact with PFY person Shelly Haggart at 989-379-0346. I did attempt to call, and got a
- voice mail recording of "this is the Birch Run PFY, please leave a message". I did indeed leave a message
- including my cell phone number and as of 4:45 PM Tuesday February 7, 2012, I have received no
- 38 response.
- 39 There is HS Soccer & Soccer Elite, PFY Football, PFY Cheerleading, PFY Baseball, PFY Softball, PFY T-Ball,
- 40 PFY Football, Men's Softball all using the Park and little to no co-ordination of Park facilities.......
- Discussion followed on the possibilities associated with a mobile vending trailer rather than a stationary
- 42 building. Discussion wondered if the potential to using the trailer off the park property for fund raising
- 43 opportunities would be possible. Certainly the Township Board would need to be consulted on this
- 44 issue. There are several possibilities for different trailer units and Fred will address some of the at the
- 45 meeting scheduled for Tuesday, February 7, 2012 @ 7:Pm.
