## ORDINANCE FOR ADOPTION OF THE INTERNATIONAL PLUMBING CODE

Ordinance No. 95-4

An ordinance of the Township of Birch Run, Saginaw County Michigan adopting the 1995 edition of the INTERNATIONAL PLUMBING CODE, regulating and controlling the design, construction, quality of material, erection, installation, alteration, repair, location, relocation, replacement, addition to, use or maintenance of plumbing systems in the Township of Birch Run; providing for the issuance of permits and collection of fees therefore; repealing Ordinance No. 91-5 of the Township of Birch Run and all other ordinances and parts of the ordinances in conflict therewith.

The Township of Birch Run does ordain as follows:

Section 1. That certain documents, a copy of which is on file in the office of the Clerk and the Township of Birch Run, being marked and designated as International Plumbing Code, including Appendix Chapters, the 1995 International Plumbing Code published by the Building Officials and Code Administrators International and the International Conference of Building Officials, be and is hereby adopted as the code of the Township of Birch Run for regulating the design, construction, quality of material, erection, installation, alteration, repair, location, relocation, replacement, addition to, use or maintenance of plumbing systems in the Township of Birch providing for the issuance of permits and collection of fees therefore; and each and all of the regulations, provisions, conditions and terms of such International Plumbing Code, 1995 edition, published by the Building Officials and Code Administrators International, Inc., International Conference of Building Officials and the Southern Building Code Congress International, Inc., on file in the office of the Township of Birch Run are hereby referred to, adopted and made a part hereof as if fully set out in this ordinance.

Section 2. The following sections are hereby revised:

Section 106.5.2 Uniform Building Code 1994 edition

Section 106.5.3 100% and 100%

Section 108.4 Misdemeanor, \$500.00, 90 days

Section 306.6.1 6inches, 6 inches

Chapter 14, Codes Uniform Building Code 1994, Uniform Mechanical Code 1991

- **Section 3.** That Ordinance No 91-5 of the Township of Birch Run entitled Birch Run Township Plumbing Code and all other ordinances or parts of ordinances in conflict herewith are hereby repealed.
- **Section 4.** That if any section, subsection, sentence, clause or phrase of this ordinance, for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance, The Township of Birch Rur hereby declares that it would have passed this ordinance, and each section, subsection, clause or phrase thereof, irrespective of the fact that any one or more sections, subsection, sentences, clauses and phrases be declared unconstitutional.
- **Section 5.** That the Township of Birch Run is hereby ordered and directed to cause this ordinance to be published.
- **Section 6.** That this ordinance and the rules, regulations, provisions, requirements, orders, and matters established and adopted hereby shall take effect and be in full force and effect 30 days from and after the date of its final passage, adoption, and publishing.
- Section 7. Exemption From State Construction Codes. Pursuant to Section 8 of Act 230 of PA 1972, the Township of Birch Run hereby elects that it shall be exempt from the State Construction Codes.
