#### PARK COMMITTEE DISCUSSION

The Township Board discussed the options for implementation of and the scope of practice of a possible Park Committee. Members of the public were also allowed feedback and gave ideas. No formal action was taken by the board on this topic. Discussion included but was not limited to:

- Allowing people to submit applications to be considered to serve on the Committee and/or volunteer for work
- It was noted that questions for applicants should be identified
- An informal "committee to create a committee" was formed consisting of Jeanie Herrick, John DiBerardino, Sarah Archer, and Autumn Mitchell.
- Discussion indicated that park rental/other fees would be reviewed, as well as the history of donations made by organizations that utilize the park facilities/grounds.
- Recognizing ideal candidates from different sectors of the community that would serve on the committee, such as athletics associations.
