A motion to extend the contract with Bixby's Garbage for another year at an annual rate of \$6030 was made by Foster and supported by Block. Unanimous approval was given.

Bixby's Garbage would want \$32,160 to have town wide pickup. If town residents want this service, a special election to approve and determine method of payment is required. Such an election is brought about by petition.

The Planning Commission's recommendation in regards to Mr. Daniels' request was explained by Maria Story, clerk. Schauer made a motion to support their recommendation. Foster supported it. Unanimous approval was given. The town is investigating Federal flood insurance programs. MESC has informed the town that they must provide unemployment compensation for their employees.
