**BIRCH RUN TOWNSHIP BOARD OF TRUSTEES**  
**RESOLUTION IN SUPPORT OF PAR PLAN RISK REDUCTION GRANT FALL CYCLE 2023**

At a Regular Meeting of the Birch Run Township Board, Township of Birch Run, Saginaw County, Michigan, held at the Birch Run Township Government Room on the 12<sup>th</sup> day of September 2023, at 7 o'clock Eastern Standard Time.

The following resolution was offered by R. Kiessler supported by C. Trinklein and approved by a vote of the Birch Run Township Board of Trustees on September 12<sup>th</sup>, 2023.

WHEREAS, the Birch Run Township Board and Birch Run Fire Department are committed to enhancing the safety and security of its personnel, facilities, and equipment; and

WHEREAS, the Par Plan Risk Reduction Grant offers an opportunity to obtain funding to improve security measures by acquiring and installing security cameras at the Birch Run Township Fire Station; and

WHEREAS, the Township Board recognizes the importance of securing our Fire Station and the valuable assets it houses;

NOW, THEREFORE, BE IT RESOLVED by the Birch Run Township Board of Trustees as follows:

1. The Township Board hereby supports the submission of a grant application to the Par Plan Risk Reduction Grant Program for the Fall 2023 Grant Cycle, for the purpose of obtaining funds to purchase and install security cameras at the Birch Run Township Fire Station.
2. The Township Board authorizes the Fire Department to proceed with the grant application process, including providing any necessary documentation and information required for the application.
3. The Township Clerk is hereby authorized to sign and submit the grant application on behalf of Birch Run Township, as the designated Program Manager, and to act as the Township's authorized representative in all matters related to this grant application.
4. This resolution shall take effect immediately upon approval by the Birch Run Township Board of Trustees.


