ORDINANCE NO. 77-4

PURPOSE:

An ordinance to adopt by reference the "Michigan Energy Code", to promote the public health, safety, morals and general welfare and safety, protection and sanitation of dwellings, buildings, structures, providing for minimum construction requirements relative to the conservation of energy.

I. SHORT TITLE:

The ordinance shall be known as and may be cited as:

"Birch Run Township Energy Code"

II. ADOPTION:

The Michigan Energy Code is hereby adopted by reference.

III. INCONSISTENT ORDINANCES:

All other ordinances of said township inconsistent with the provisions of this ordinance are, to the extent of such inconsistency, superseded by this said ordinance.

IV. PENALTY:

- A. Any person who violates any provision of this ordinance shall, upon conviction, be punished by a fine of not more than Two Hundred and 00/10((\$200.00) Dollars or by imprisonment for not more than nnety (90) days in jail, or both. Each day's failure of compliance with any provision of this ordinance shall constitute a separate offense.
- B. Legal proceedings to enjoin the violation of any of the provisions this ordinance may be brought in any court of competent jurisdiction in the name of the Township of Birch Run. Such action for injunctive relief shall be brought when authorized by the Birch Run Township Board. The enforcement and administration of the provisions of this ordinance shall otherwise be under and by the Birch Run Township Building Inspector.

V. INVALIDITY:

If any section, paragraph, sentence, clause, phrase or part of this ordinance shall be declared invalid for any reason whatsoever, such a decision shall not affect the remaining portions of this ordinance which shall remain in full force and effect; and to this end, the provisions of this ordinance are hereby declared to be severable.

VI. EFFECTIVE DATE:

This ordinance shall be effective immediately upon the publication thereof, it being determined that it is absolutely necessary for the health and welfare of the inhabitants of the Township of Birch Run that immediate effect be given hereto.

This ordinance is hereby declared to have been adopted by the Townsh Board of the Township of Birch Run, County of Saginaw, State of Michigan, at a regular meeting thereof held on the // day of June, A.D., 1977, and ordered to be given publication in the manner prescribed by law.
