The supervisor read a letter from village requesting use of surplus water funds to reimburse their payment of a water main break. The motion to allow this expenditure of surplus funds was made by Foster, supported by S harrer. The motion passed unanimously.

The carpeting problem in the library was discussed. It was decided to get someone else to look at it.

A motion to amend the election budget to \$2590 was made by Foster, supported by Block. The motionpassed unanimously.

Marshall Greene made a presentation in regards to furniture for the library.

A motion to adjourn was made at 9:30 by Foster. and supported by Block. The motion passed unanimously.
