REGULAR MEETING DECEMBER 12, 1995

SPECIAL ASSESSMENT ROLL HEARING

Supervisor declared the hearing closed at 7:07 p.m.

The board reviewed two proposals for insurance. Motion by DiBerardino, supported by Henige to accept the Burnham and Flower proposal for an annual premium of \$14,396.00, payable upon presentation of invoice. Motion carried 6-0.

The board discussed a petition received November 28. The legal opinion of township attorney Michael Shovan was read. Motion by Russell to make a decision as a board on whether to accept the attorney's opinion, or to honor the petition request died for lack of support.

Motion by St.Charles, supported by Stewart to approve Resolution #95-15, a resolution confirming special assessment roll. Motion carried 5-0.

Motion by St.Charles, supported by Russell to authorize the Birch Run Water Authority to spend up to \$25,200.00 for the painting of the blue water tower. Motion carried 6-0.

The board discussed Administrative Resolution #88-4. Motion by Russell, supported by DiBerardino to table this agenda item to a future time. Motion carried 6-0.

Motion by Henige, supported by Stewart to approve the appointments of Nick DiBerardino and Matt Zoellner to the Birch Run Fire Department. Motion carried 6-0.

Manager reported on a December 19 Board of Determination Meeting which will discuss a portion of the Alexander Drain in Birch Run.

Motion by Stewart, supported by Henige to adjourn at 9:37 p.m. Motion carried 6-0.
