suggested. The motion passed unanimously.

E. Schauer moved that Frankenmuth Bank and Trust Buck Run branch be the depository for township funds. Alvin Block seconded the motion which passed unanimously.

Alvin Block made motion to turn over \$3,000 allocated to the park board to them immediately. Edgar Schauer supported it. The motion passed unanimously.

Edgar Schauer moved and Alvin Block supported him to give \$500 to the Frankenmuth Recreation Program. The bill passed unanimously.

Edgar Schauer moved and Alvin Block supported him to authorize the supervisor to purchase a duck up truck for the Township for not more than \$1,000. The motion passed unanimously.

Edgar Schauer made motion that the Supervisor purchase a tractor and lawn mower from Bader Brothers for \$1547. Alvin Block supported. It passed unanimously.

(Rod Foster returned from the fire.)

Maria Strong made motion and Alvin Block supported to accept Ken Hauke's resignation from the Bd. of Review. The motion passed unanimously.

It was moved by Block and supported by Foster to authorize the supervisor and treasurer to make the decision on the purchase of a copy machine. Unanimous approval was given.

Schaefer made motion to authorize supervisor to purchase answering machine for not more than \$100. Foster supported. Unanimous approval was given.

Block made motion to allow treasurer to purchase a printing calculator not to exceed \$300. Foster seconded the motion. It passed unanimously.

Block made motion that Schaefer be allowed to use his discretion in putting \$15,000 into C.D.s for ~~Foster~~ 90 days or longer. Foster seconded the motion. The motion passed unanimously.

Roger Foster moved and Alvin Block supported to give the Little Assoc. their \$1,000 allocation immediately. Unanimous approval was given.

Ed Schaefer made motion to charge \$15 for permit and inspection fees in all deceased Charles Park. Foster supported. Unanimous approval was given.

Schaefer made motion to buy 788.90 pressure washer for fire department from Bader Brothers. Block seconded it. Unanimous approval was given.
