poles, towers, mains, wires, pipes, conduits and other apparatus requi-
site for the transmission, transforming and distribution of electricity
for public and private use, subject, however, to all the applicable laws
and Constitutional provisions of the State of Michigan.

This permission shall be subject at any time to revocation at
the will of the Township of Birch Run.
