A motion to give supervisor authority to have parking lot striped was made by Strong, supported by Block. Motion passed tnanimously.

A motion to approve use of \$2500 from surplus construction funds in system #1 for purchase of new pump discharge control valve and to make known that the township board has no objection to use of FmHA funds for this purpose was made by Strong, supported bny Scharrer. Motion passed unanimously.

A motion to adjourn was made at 8:30 by Block, supported by Scharrer. Motion passed unanimously.
