Supervisor read a letter from Liquor Control Commission informing us that the township has available one more license for the sale of beer, wine and spirits on the premises. The township board must approve any such license. The township board will no act until all applicants have come forward.

Supervisor reported that residential values will increase 9.09% next year. Figures are not yet available for agricultural, timber cut over and commercial.
