A motion to pay the bills as presented was made by Block, supported by Scharrer. Motion carried.

Supervisor explained his discussions with the fire department in regards to administration of the fire department. The board will appoint Thomas Totten as assistant chief. He will have the same duties as the chief, Mr. Schmitzer. This action was taken by motion of Dorr, supported by Scharrer. Motion carried unanimously.

A motion requiring the chief to confine his activities to the fire station or retire was made by Block supported by Strong. Motion carried.

Two bids for annual audit were presented. The low bid of \$2650 from Laine and Appold was accepted by motion of Strong supported by Block. Motion carried.

Two bids for the new cemetery mowers were sent to the board by Don Morse, sexton. A motion to purchase the 332 mover from Bader Brothers was made by Scharrer, supported by Dorr. Motion carried.

By motion of Dorr and supported by Block Marcia Strong was designated to coordinate handicapped requiremetrs and to adopt the self-evaluation plan as presented. Motion carried. A copy of the plan is a ttached.

Mr. Schmitzer came to the meeting at this point. The new regulations were explained to him.

A motion to give the clerk and the treasurer authority to pay bills due before end of fiscal year was made by Dorr, supported by Block. Motion carried.

A motion to transfer \$1000 from contingency to insurance was made by Block, supported by kDorr. Motion carried.

A motion to reappoint Fred olenrand and jerry Trinklein to the Planning Commission for three year terms was amde by Dorr, supported by Block. Motion carried.

A motion to give the clerk authority to hire an resistant in library for April-May for 10 hours per week was amde by Blcok and supported by Dorr. Motion carried.

Large gorup gatherings in the township were discussed. The super-visor will investigat eour legal position.

Supervisor read minutes of last planning commission meeting.

The supervisor presented the budget for 84-85.

A motion to adjourn was amde at 9:10 p.m. by Scharrer and supported by Dorr. Motion carried.
