- 6 Meeting opened at 7:00 by Chairman Fred with pledge of allegiance.
- 7 Fred presented the Park Board members with an agenda.
- 8 No quorum present.
- 9 Ramon presented a budget for the playground.
- 10 The concession stand is on hold, the steel was donated. The concession stand will require an additional
- 11 2-3 days to finish. Concrete is done.
- 12 Ramon asked if there is an answer to determine the potential for guidelines for use of the concession
- stand. Fred commented on what he remembered. But said there is a definite need for finalization on
- 14 determining the who's how's and what's for concession stand use. Ramon continued to comment on the
- 15 way it works in Clio. Fred did say the use needs to be finalized to set policy to use and stock the
- 16 concession stand. Ramon is checking to see if Clio has a written policy to start this discussion with.
- 17 The playground is done with the exception of final clean up.
- 18 Fred will check to see if Mrs. Keisling has completed the survey.
- 19 Park Signs. It has been suggested that there be signs to tell park users where they are. Bill offered at
- 20 least one 4X8 sheet of plexiglass.
- 21 The tennis court nets are to be replaced in 2013. Ramon had turned bids into Mr. Kiesling some time
- 22 back on nets.
- 23 Lighting has been suggested for under the pavilion, it had been suggested we purchase only explosion
- proof fixtures for this area in order to reduce vandalism potential.
- 25 The Park Committee needs a small drag of some sort to use to address the ball fields. Fred suggested
- 26 maybe a Facebook posting could yield some results.
- 27 Apparently there is a flyer circulating that someone named Jamie is using the park for personal profit
- with some kind of exercise program. Fred will work with Supervisor Letterman on this issue.
- 29 The Athletic Assn. wants to have a circus at the park in August. Fred will take this to the Twp. Board to
- 30 see what their pleasure is on this matter. Ramon said there has been a question of liability issues. Also
- 31 what about the use of the park for fund raising issues. Lines 27 & 28 above reference this issue too.
- 32 Someone wants to know if the Twp. Allows for fund raising, then why would it be a problem for a for
- 33 profit organization to use the park too? Fred will make a call on this issue tomorrow.

- 34 Bill asked about Brass etched maps for the maps referenced in line 19 above. Fred will check on these
- 35 too.
- No other issues were presented for the Park Board's consideration. Adjournment at 7:30pm.
