At a Regular Meeting of the Birch Run Township Board, Township of Birch Run, Saginaw County, Michigan, held at the Township Meeting Room on the 13<sup>th</sup> day of October, 2009, at 7 o'clock Eastern Standard Time.

WHEREAS, state and community leaders need to spread the word about the excellent programs they have established, the growth of markets for recyclables, the importance of buying recycled products, the need to expand the collection of recyclable materials, and the benefits of investing in recycling by small and large businesses;

WEREAS, the Mid Michigan Waste Authority and its member communities support programs to foster waste reduction, reuse, recycling and buying recycled activities by residents, schools, businesses and other organizations across the greater Saginaw Valley area;
