RESOLUTION NO. 93-6 ESTABLISHING THE BIRCH RUN WATER AUTHORITY

The following resolution was offered by <a href="Gary St.Charles">Gary St.Charles</a> and seconded by <a href="Sheila DiBerardino:">Sheila DiBerardino:</a>

WHEREAS, the Village of Birch Run, Saginaw County, Michigan, and the Township of Birch Run, Saginaw County, Michigan, have a joint interest in a certain water supply system hereto constructed by the County of Saginaw for the Village and Township, pursuant to the Birch Run Township and Birch Run Village Water Supply System Contract dated February 3, 1976; and

WHEREAS, the Village of Birch Run and the Township of Birch Run entered into an additional contract on January 23, 1976 as to certain matters regarding the system; and

WHEREAS, the Village of Birch Run and the Township of Birch Run have entered into an additional contract dated September 16, 1993 as to the adjustment of the respective obligations of the Municipalities and agreeing to the establishment of a Municipal Water Authority.

## NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The Township of Birch Run, pursuant to Act 233, Public Acts of Michigan, 1955, as amended, agrees to establish in conjunction with the Village of Birch Run, a Municipal Water Authority.
- 2. The purpose of this Authority will be to operate the Water Supply System as described in the agreement dated September 16, 1993, including the two water towers located in the Village of Birch Run. This shall be limited to contracting for water supply and approval of water extensions based on existing water capacity.
- 3. The Authority's governing body shall be comprised of four (4) members. The Village President and the Township Supervisor shall serve as ex officio members. Each Municipality shall appoint one member who shall be a resident of the Municipalities and not a member of the Village Council or Township Board.

## ALSO, BE IT FURTHER RESOLVED THAT:

1. The appropriate officials be authorized to sign the documents necessary to establish this Authority.
