Resolution Establishing Hearing on Special Assessment Roll

Birch Run Township Busch Road Water Main Extension District

#2008-13

At a regular meeting of the Township Board of the Township of Birch Run, Saginaw County, Michigan, held at the Township Government Room, Birch Run Township, Michigan, on the 9th day of September, 2008, at 7:00 p.m., Michigan time.

PRESENT: Schlegel, Cook, Magnus, Marr, Putnam, Trevino, and Strahm

The Supervisor indicated to the Board that it is now necessary to hold a public hearing to review and approve the special assessment roll for the Birch Run Township Busch Road Water Main Extension project. The district boundaries for the special assessment improvement were previously approved by the township board.

The Supervisor then presented to the board a special assessment roll which has been prepared for the Water Main Extension project. Attached to the roll is the Supervisor's Certificate as required by law.

The following resolution was offered by Magnus and seconded by Marr:

BE IT RESOLVED BY THE TOWNSHIP BOARD OF THE TOWNSHIP OF BIRCH RUN, SAGINAW COUNTY, MICHIGAN, as follows:

1. The special assessment district description, which is attached to this resolution as Attachment A, is hereby fixed and approved.

2. The special assessment roll in the amount of \$100,531.64, made by the supervisor, has been presented to the township board for the following improvement:

Construction of a water main beginning at the intersection of Busch and Maple Roads and continuing easterly a distance of approximately 3,960 feet to the East 1/8 line of Sections 5 and 8, Birch Run Township.

The above improvements are located within the previously approved special assessment district, described in Attachment A.

3. The special assessment roll and the special assessment improvement and special assessment district to which the roll applies hereby are designated as the Birch Run Township Busch Road Water Main Extension Special Assessment District.

4. The Township Board shall meet at the Township Government Room on the 14th day of October, 2008, at 7:00 p.m., Michigan Time, for the purpose of reviewing the special assessment roll and to hear and consider any objections to them. Notice of the hearing will be given by publishing the same twice prior to said hearing in The Birch Run Herald, a newspaper circulated in the Township, and mailing it to all persons whose names appear on the special assessment roll as the owners of property in the special assessment district at the addresses in the roll. The first publication and such mailing to shall be at least ten (10) days prior to the time of the hearing.


