Motion by Foster, supported by Scharrer to pay bills as presented passed unanimously.

County Commissioner Worley spoke to the board on several matters.

Supervisor menitoned panel truck was no longer of use to township. A motion to put the truck up for bids with a minimus bid of \$500 was made by Foster, supported by Scharrer. Motion passed unanimously. Clerk will accept bids with bid deadline November 1, 1980. clerk will notify h ighest bidder.

Supervisor discussed increase in water costs. A motion to raise rate \$1.50 per quarter in each system was made by Block, supported by Foster. Motion passed unanimously. (\$57 to 58.50 and 40 to 41.50)

A motion to amend township miscellaneous budget to \$3200 from \$2600 was made by Scharrer, supported by Block. Motion passed unanimously.

A motion to amend auditing budget to \$2300 from \$2000 was made by Scharrer, supported by Block. Motin passed unanimously.

A motion to amend fire dept. capital outlay budget from \$7500 to \$8500 was made by Scharrer, supported by Foster. Motion passed unanimously.

A motion to amend township drain at large budget from \$7,000 to \$24,000 was made by Foster, supported by Strong. Motion passed unanimously.

A motion to adjourn was made at 9:15 p.m. by Scharrer, supported by Foster. Motion passed unanimously.
