Supervisor discussed extending the water line in the cemetery 400 ft.

A motion to allow resale of cemetery lots to township board only was made by Block, supported by Scharrer. Motion passed unanimously.

A motion to raise the rent to \$35 for township hall was made by Scharrer, supported by Block. Motion passed unanimously.

A motion to allow the clerk and treasurer the authority to pay bills which arise before end of fiscal year was made by Dorr, supported by Block. Motion passed unanimously.

A motion to re-appoint Don Bailer and Gary Hutchinson to the Planning Commission for three year terms was made by Scharrer, supported by Dorr. Motion passed unanimously.

The budget for 1982-83 was discussed.

A motion to adjourn was made by 8:10 by Block, supported by Scharrer. Motion passed unanimously.
