RESOLUTION AFFIRMING ANNEXATION

NOW, THEREFORE, by Motion duly made by Thomas Totten, supported by Marcia Strong and by Unanimous (Y-0) vote, be it resolved that the TOWNSHIP OF BIRCH RUN, does hereby affirm and approve the annexation of certain real property, heretofore located within the TOWNSHIP OF BIRCH RUN, to the VILLAGE OF BIRCH RUN, said real property being described as follows, to-wit:

Parcel #1

That part of the Southwest 1/4 of the Northwest 1/4 of Section 28, Township 10 North, Range 6 East, Birch Run Township, Saginaw County, Michigan, more particularly described as follows: Beginning at the West 1/4 corner of said Section 28; thence North along the West Section line 699.00 feet; thence East 666.34 feet to a point on the East line of the West 1/4 of the Northwest 1/4 of said Section; thence South 0°02'20" East, along said East line 696.78 feet to a point on the East-West one-quarter line; thence South 89°48'34" West, along said East-West one-quarter line 666.82 feet to the point of beginning.
