 to rezone from Agricultural to Commercial  
 Land in the Township of Birch Run County of Saginaw  
 and State of Michigan and described as follows, to wit  
 A part of the West 1/4 of the S 1/4 1/4 Section 8 T-10 N  
 R 6 E described as follows. Commencing at the West  
 1/4 post of Section 8 T 10 N. R 6 E. Birch Run Township  
 Saginaw County Michigan thence S 0° 28' 10" E.  
 1042.59 feet along West Section Line Section 8 to the  
 centerline of Dixie Highway thence 29° 31' 40" S -  
 277.13 feet along said centerline thence N 60° 28'  
 20" E. 1373.97 feet perpendicular to centerline of  
 Dixie Highway to West 1/4 line thence N 0° 30' W  
 634.13 feet to frontline thence S 89° 07' W  
 1335.62 feet to point of beginning containing  
 30.18 acres more or less subject to any easements  
 or use restrictions of record. The above named parties  
 request a specific zoning for the commercial use  
 of the above described land for the conduct of a road oiling  
 business. The land will involve rendering tanks  
 gas storage tanks and overhead oil storage; the erection  
 of necessary buildings and the parking of trucks  
 all used in the road oiling business.
