Mr. Setzer cited specifically Articles 4, 5, 14, and 21 of The Zoning Ordinance. Six conditions to the Special Use Permit were recommended, which will be found in the Commission's motion. Staff recommends approval of the Special Use Permit.

- 1.) Compliance with the criteria as found in Article 21 of the Township Zoning Ordinance. (Definition of Bed and Breakfast)
- 2.) Compliance with the ordinance which are referenced in Article 14; Article 4/ site plan review, Article 5/ special land uses and a specific land use standard of Article 14, Section 14.01, which applies directly to a Bed and Breakfast.
- 3.) Signage must be approved by the Building Department.
- 4.) Approved window ladders must be provided for each sleeping room on the second floor.
- 5.) Fire extinguishers must be provided as required by law.
- 6.) All code inspections must be approved prior to issuance of the Special Use Permit.
