Site Plan Review

Al Hunter went over the letters and application with the site plan. Everything was in order. Dennis Fent presented the site drawings to the group. Input from Jim Totten was reviewed and discussed. Items of note are:

- Building use is strictly manufacturing with an office and meeting room.
- Parcel is zoned M-1
- Parcel is going to be split into two parcels

The Planning Commission conditionally approved the **Site Plan** for Dennis Fent and David Fent. Jeff Putnam moved to grant approval to Dennis and David Fent for the property at 11820 Dixie Hwy with the following conditions:

- 1. Parking spaces must be of adequate size, 200 sq. ft.
- 2. Side setback cannot yet be determined pending land division but must follow Zoning Ordinance Section 1505, Dimensional Requirements for M-1 Industrial District.
- 3. Parking space distance from the new lot line must be at least 10 feet.
- 4. The proposed split line or land division must be approved.
- 5. All necessary permits must be applied for.

The motion was seconded by Bronner. Approved 4-0.
