The following resolution was made by Putnam and seconded by Marr:

**WHEREAS** on April 11, 2006 the Birch Run Township Board of Trustees adopted the Birch Run Township Cemetery Ordinance #2006-02, and

**WHEREAS**, the Birch Run Township Board of Trustees periodically review the fee schedules surrounding the administration of burials and the maintenance on the Birch Run Cemetery ensuring the fees schedule is current, and

**THEREFORE, BE IT RESOLVED**, that the Birch Run Township Board does hereby adopt the following fee schedule for establishing the proper fees for the Birch Run Township Cemetery:

**Cemetery Fees:**

**Graves per space: ~~\$200.00~~ \$300.00**

**Nonresidential cost per lot: ~~\$500.00~~-\$600.00**

**Adult Burials: \$550.00 (Includes machine time)**

**Child Burials: \$250.00 (Burial in Special "Child" Section only)**

**Cremation Burial: \$100.00**

**Chapel Use: \$50.00 (Required between November 1<sup>st</sup> and March 1<sup>st</sup>)**

**Machine Time: \$50.00 per hour**

**Extra Man: \$10.00 per hour.**

**Sunday and Holidays: \$75.00 more**
