

ORDINANCE NO. 83- 1

TOWNSHIP OF BIRCH RUN

SAGINAW COUNTY, MICHIGAN

AN ORDINANCE TO AMEND ORDINANCE NO. 81-2, ENTITLED "TOWNSHIP OF BIRCH RUN CABLE COMMUNICATIONS REGULATORY ORDINANCE" AS TO SECTION 5 ENTITLED " GRANTING OF PERMIT" AND SECTION 15, "APPLICATION FEES, COSTS AND EXPENSES OF TOWNSHIP."

THE TOWNSHIP OF BIRCH RUN ORDAINS:

SECTION 1. That Section 5 - Granting of Permit of Ordinance No. 81-2 be and the same is hereby amended to read as follows:

SECTION 5 - GRANTING OF PERMIT

The Township Board shall grant a Cable Antenna Television System Permit hereunder to each applicant who makes proper application, establishes its qualifications as herein set forth, furnishes the required insurance and assurances and establishes that its operations will not impose an unreasonable burden on Township streets and roads. No permit granted hereunder shall be exclusive. In accordance with the provisions of Article 7, Section 19, of the Constitution of 1963 of the State of Michigan, any permit granted may be revoked by the Township, unless the proposition shall have been approved by a majority of the electors of the Township voting thereon at a regular or special election. The Township shall, before it may revoke the Permit granted, give to the Permittee thirty (30) days notice that it intends to move to revoke the Permit, and the reasons therefor. The Permittee shall thereafter have sixty (60) days, after the expiration of the thirty (30) days notice, to completely correct or eliminate the reasons for which the Township has given its notice to revoke said permit issued.

SECTION 2. That Section 15 - Application Fees, Costs and Expenses of Township of Ordinance No. 81-2 be and the same is hereby amended to read as follows:

SECTION 15 - APPLICATION FEES, COSTS AND EXPENSES OF TOWNSHIP

The Permittee shall pay to the Township, for the privilege of operating a Cable Antenna Television System, under the Permit hereunder granted, the sum of Five Hundred and 00/100 Dollars, (\$500.00). Of that said sum, the sum of Two Hundred and 00/100 Dollars, (200.00), shall be paid at the time the Permit is granted. The remaining Three Hundred and 00/100 Dollars, (\$300.00), shall be paid on or before one year after the issuance of the Permit. Such fees shall not be refundable. Further, the Permittee shall pay to the Township other necessary and reasonable costs, charges, and expenses, incurred by the Township by or as a result of the Permittee's activities hereunder.

In addition each Permittee shall pay a Ten and 00/100 Dollars, (\$10.00), annual fee to the Township, on the yearly anniversary date of the Permit issued.

SECTION 3. That all of the remaining paragraphs and provisions of Ordinance No. 81-2 shall remain in full force and effect.

SECTION 4. This Ordinance shall be published and take effect thirty (30) days from and after the date of publication.
